FIRST AMENDMENT TO THE INTERCONNECTION AGREEMENT

This First Amendment ("First Amendment") to the Interconnection Agreement for the Transport and Termination of Traffic Between Wireline Carriers, by and between Amery Telcom, Inc. ("AMERY") and Charter Fiberlink, LLC ("CHARTER"), approved by the Public Service Commission of Wisconsin in 5-TI-1770 on February 5, 2008 (the "Agreement"), is made as of the 1st day of April, 2009 (the "First Amendment Effective Date").

For and in consideration of the mutual promises contained herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, AMERY and CHARTER agree as follows:

1. **Defined Terms.** All capitalized terms used herein and not expressly defined herein shall have the respective meanings given to such terms in the Agreement.

2. **Terms Amended.** The Agreement is amended, as of the First Amendment Effective Date, as follows:

Appendix C to the Agreement is hereby deleted in its entirety and an "Amended Appendix C (4-1-09)," which is attached to this First Amendment, is substituted in lieu thereof.

Appendix F to the Agreement is hereby deleted in its entirety and an "Amended Appendix F (4-1-09)" which is attached to this First Amendment, is substituted in lieu thereof.

3. **Counterparts.** This First Amendment may be executed in one or more counterparts, each of which taken together will constitute one and the same instrument.

4. **No Other Amendments.** Except as provided in this First Amendment, the Agreement is unmodified and remains in full force and effect.

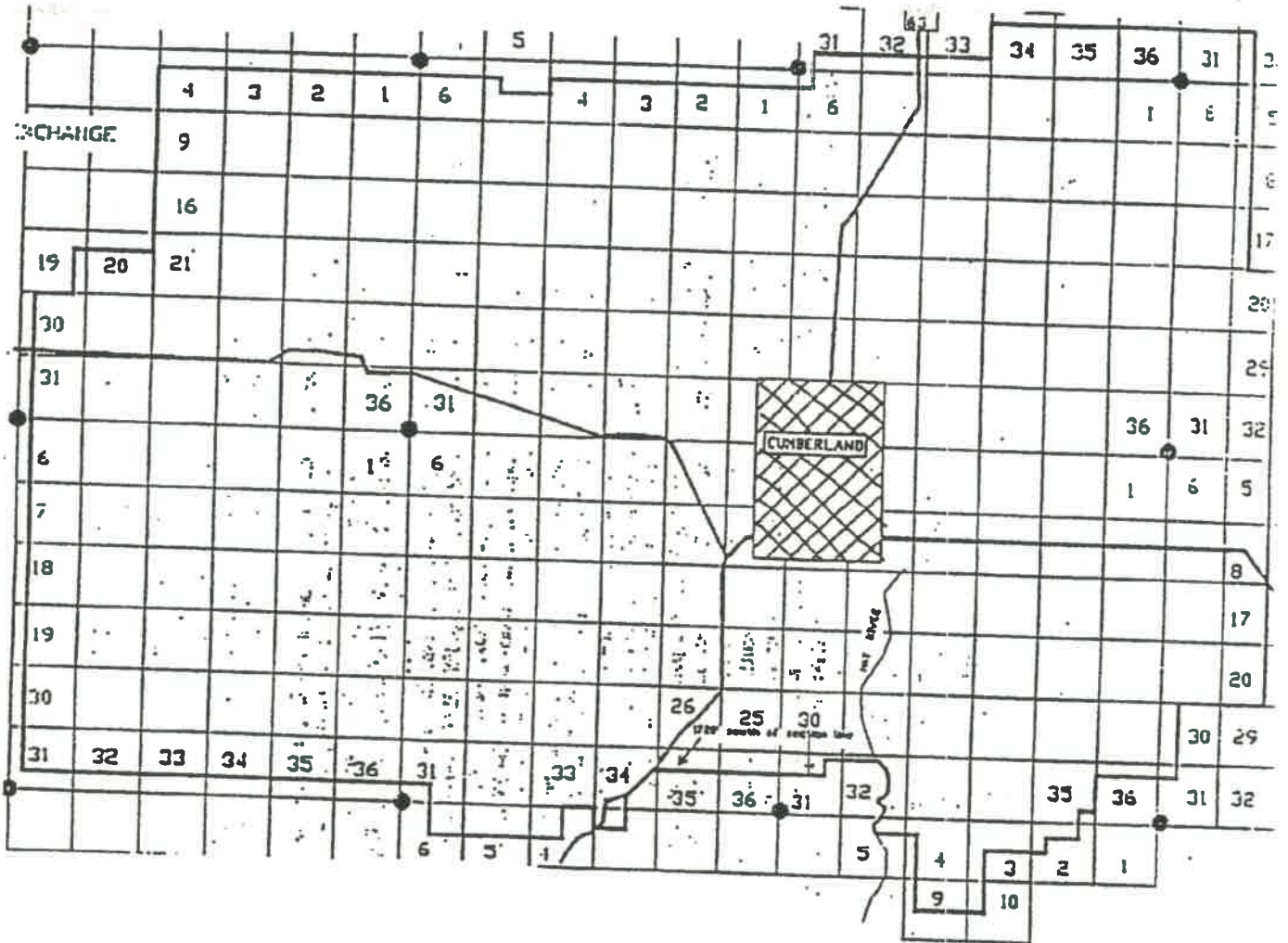

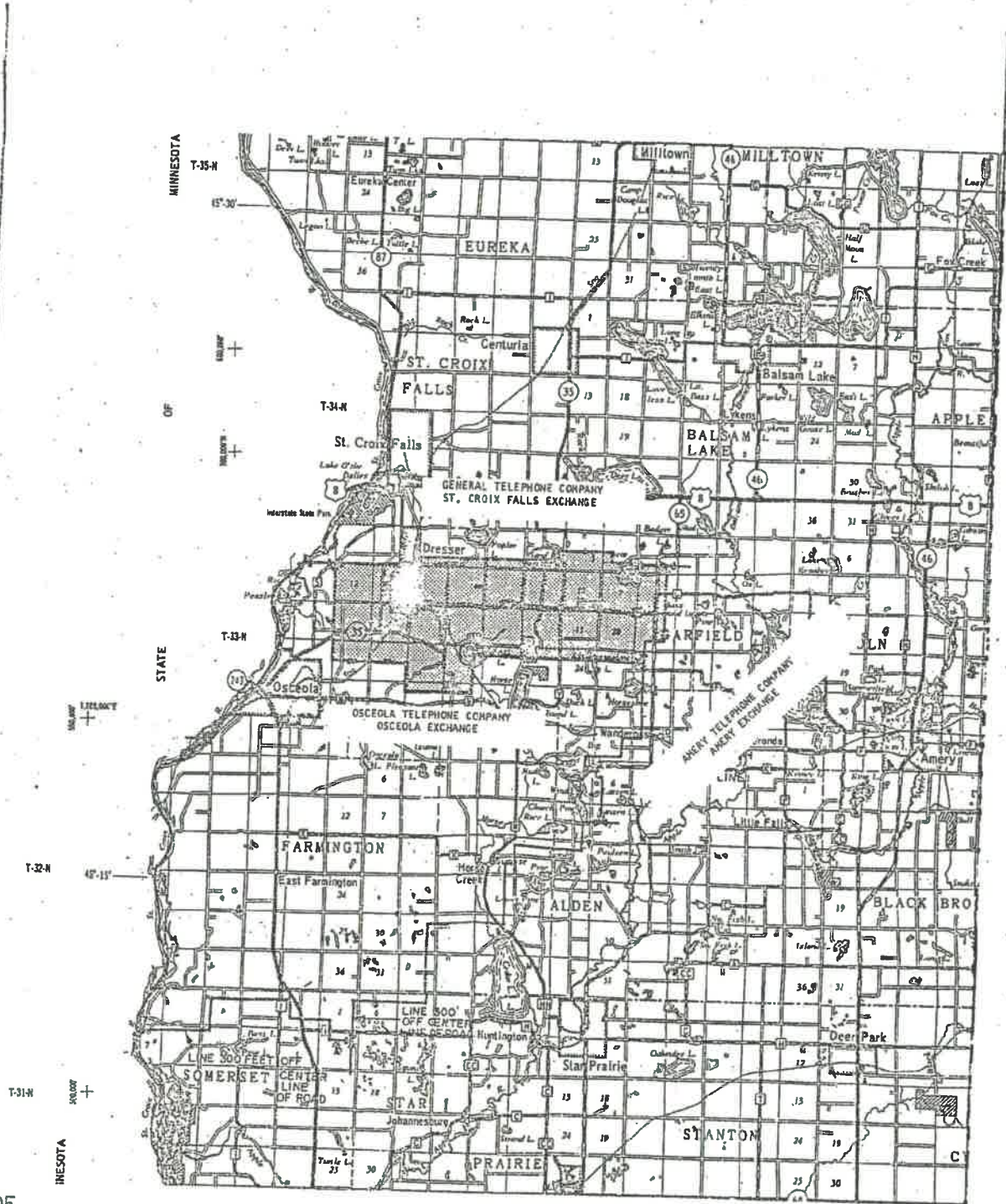
