**AMENDMENT TO
INTERCONNECTION AGREEMENT
BETWEEN
WISCONSIN BELL, INC. d/b/a AT&T WISCONSIN
AND
Norlight Telecommunications, Inc.**

WHEREAS, Wisconsin Bell, Inc. d/b/a AT&T Wisconsin ("AT&T Wisconsin") and Norlight Telecommunications, Inc. ("CLEC") (collectively referred to as the "Parties") entered into an Interconnection Agreement which became effective on March 7, 2005 (the "Agreement"); and

WHEREAS, the Agreement permits the Parties to mutually amend the Agreement in writing.

NOW, THEREFORE, the Parties agree to amend the Agreement based upon the following terms and conditions:


- (1) Appendix Pricing to the Agreement is hereby amended to replace and supersede the DS3 UNE Loop Recurring Rates, respectively, currently set forth in such Appendix Pricing under the heading "Loops", with the following DS3 UNE Loop:

Rate Group	Unbundled DS-3 Loops (Corrected)
Band A	\$438.33
Band B	\$528.88
Band C	\$545.69

- (2) This Amendment, including without limitation the DS3 UNE Loop recurring rates set forth herein shall become effective ten (10) days following the date this Amendment is approved or is deemed to have been approved by the Wisconsin Public Service Commission.
- (3) In entering into this Amendment, neither Party waives, and each Party expressly reserves, any rights, remedies or arguments it may have at law or under the intervening law or regulatory change provisions in the underlying Agreement (including intervening law rights asserted by either Party via written notice predating this Amendment) with respect to any orders, decisions, legislation or proceedings and any remands thereof, which the Parties have not yet fully incorporated into this Agreement or which may be the subject of further review.
- (4) EXCEPT AS MODIFIED HEREIN, ALL OTHER TERMS AND CONDITIONS IN THE UNDERLYING AGREEMENT REMAIN UNCHANGED.
