The purposes of an analytical review are to detect possible reporting or accounting related errors and to identify significant fluctuations from established trends in reported data not sufficiently explained in the annual report. It is our hope that our review will supply information that will enable us to better provide guidance to your utility regarding proper utility accounting and the preparation of future annual reports. In order to complete this review, we request the following information:

1. As of today's date our office has not received a response to our letter of December 30, 1997 concerning our review of your 1996 annual report. Please provide your response at this time.
2. During our review we noted that while you report services as added during the year in column (d) of the Water Services schedule on page W-15, you do not report any dollar additions during the year for Account 345, Services in column (c) of the Water Utility Plant In Service schedule on page W-8. This was also brought to your attention in the letter referenced above concerning the 1996 annual report. Please note the enclosed copy of page 36 of the Uniform System of Accounts which details which costs related to the installation of services should be debited to Account 345.
3. During our review of the Water Utility Plant In Service schedule we noted that in 1996 you report end of year balances of \$500 for Account 303 and \$1,010 for Account 310, but in 1997, those same dollar amounts were reported in Accounts 301 and 311 respectively. Please explain and provide all related annual report corrections.

We appreciate your cooperation in providing the above information. These recommendations are intended to provide accounting assistance and should not be construed as criticisms of utility personnel. If you have any questions, please feel free to contact me at (608) 267-9198. Please respond within 30 days of this letter. If we have no questions regarding your response, you can consider the review closed.
