The Public Service Commission (Commission) is in the process of completing an analytical review of your utility's 1999 annual report. The purposes of an analytical review are to detect possible reporting or accounting related errors and to identify significant fluctuations from established trends in reported data not sufficiently explained in the annual report. It is our hope that our review will supply information that will enable us to better provide guidance to your utility regarding proper utility accounting and the preparation of future annual reports. In order to complete this review, we request the following information:

1. During our review, we noted "bulk sales" reported in Account 474, Other Water Revenues. In the future, please report bulk sales as either unmetered or metered sales of water, Account 460 or 461, page W-2.
2. During our review, we noted a meter retired on the Meters schedule. A footnote to the schedule indicates the meter was sold "from in stock." However, corresponding dollars are not reported retired from Account 346, Meters, Water Utility Plant in Service schedule. Meter dollars are to be recorded in Account 346, even when meters are in stock. Please explain why meter dollars were not retired from Account 346.
3. During our review, we noted that three ¾" services are reported added on the Water Services schedule. A footnote to the schedule indicates the property owners paid for the services. However, \$1,800 is reported for services contributions in Account 271, Contributions in Aid of Construction. Your Water Lateral Installation Charge, Cz-1, allows \$450 for a ¾" service. Please explain why more than \$1,350 (3 x \$450) is reported as contributions.

In addition, \$940 is reported as additions to Account 345, Services, Water Utility Plant in Service schedule. This seems low for the three services added. Please provide an explanation.

We appreciate your cooperation in providing the above information. These recommendations are intended to provide accounting assistance and should not be construed as criticisms of utility personnel. If you have any questions, please feel free to contact me at (608) 266-3768. Please respond within 30 days of this letter. If we have no questions regarding your response, you can consider the review closed.
