Electric Operation & Maintenance Expenses (Page E-03)

Increases of \$33,784 or 126% in Operation Supervision Expenses (560), \$5,848 or 121% in Accounting and Collecting Labor (902), and \$5,847 or 121% in Administrative and General Salaries (920) are due to adding a new electrical superintendent and a full-time electric utility employee.

Line and Station Supplies and Expenses decreased \$19,803 or 46%. This is due to fewer supplies being purchased.

Outside Services Employed (923) increased \$16,473 or 344%. This increase is due to hiring Cole Consulting to evaluate the Mazomanie Electrical Utility and make recommendations.

Employee Pensions and Benefits (926) increased \$6,134 or 36%. This increase is due to the additional employee pensions and benefits that were paid to the new electrical superintendent and full-time electric utility employee.

Electric Utility Plant in Service (Page E-06)

Overhead Conductors and Devices (365) increased \$53,196. Additions were for Plastic Ingenuity facility.

Transportation Equipment (392) increased \$59,932. In 2000 the electric utility purchased a line truck (\$51,757) and a pickup truck (\$8,175).

Miscellaneous Equipment (398) increased \$14,890. In 2000 the electric utility purchased a chipper (\$11,355) and a locator (\$3,535).
