analytical review are to detect possible reporting or accounting related errors and to identify significant fluctuations from established trends in reported data not sufficiently explained in the annual report. It is our hope that this review will supply information that will enable us to better provide guidance to your utility regarding proper utility accounting and the preparation of future annual reports. In order to complete this review, we request the following information:

- 1) As of today's date our office has not received a response to our letter of July 24, 2001, concerning our review of the utility's 2000 annual report. A second copy of that letter was sent in response to a request from Dor Krisak on October 18, 2001. Please provide a response to that letter at this time.
  
- 2) During our review, we noted that the explanation provided for Account 620, Fuel or Power Purchased for Pumping in the footnotes for page W-5 shows that the costs reported in that account includes more than just the power for pumping. In the future, please include only the cost of the power for pumping in that account.
  
- 3) Please explain why there are no dollars reported in Account 686, Employees Pensions and Benefits on page W-5.
  
- 4) During our review we noted that while the utility reports \$49,817 for Utility Plant, Jan 1 on line 22 of the Property Tax Equivalent schedule on page W-7, the Total Utility Plant total of lines 1 through 8 of the Net Utility Plant schedule from the 2000 annual report is \$50,317. Please confirm that in the future you will report that total from the previous year annual report in the Property Tax Equivalent schedule.

We appreciate your cooperation in providing the above information. These recommendations are intended to provide accounting assistance and should not be construed as criticisms of utility personnel. If you have any questions, please feel free to contact me at (608) 267-9198. Please respond within 30 days of this letter. We prefer that you respond by e-mail if it is convenient for you to do so.
