Water Operation & Maintenance Expenses (Page W-05)

Repairs of Water Plan (650) was higher in 2001 due to a main break that was repair and had additional problems with the mains in 2001.

Outside Services (682) was higher in 2002 due to \$2560 spent on pump house work and water leak work and addition costs for increased water and pond testing.
