The Public Service Commission has completed their analytical review of your 1999 annual report. The primary purpose of our analytical review is to detect possible accounting related errors and to identify significant fluctuations from prior year's data, which are not sufficiently explained in the footnotes of your annual report. We have no questions, only the following comment.

During our review, we noted \$7,350 reported in Account 474, Other Water Revenues, described as "insurance settlement for roof damage." In the future, insurance reimbursements for plant that has been retired should be reported in Account 110, Accumulated Provision for Depreciation as salvage. Insurance reimbursements for plant repairs that have been expensed should be credited to the expense account originally debited. Please follow this procedure in the future.
