The Public Service Commission staff is in the process of completing an analytical review of your utility's 2000 annual report. The purposes of an analytical review are to detect possible reporting or accounting related errors and to identify significant fluctuations from established trends in reported data not sufficiently explained in the annual report. It is our hope that this review will supply information that will enable us to better provide guidance to your utility regarding proper utility accounting and the preparation of future annual reports. In order to complete this review, we request the following information:

1. In the future, when completing the Property Tax Equivalent schedule on page W-7, even though the tax equivalent has been set to zero by the municipality, please provide the assessment ratio as this is information used by auditors in future rate cases.
2. During our review of the Water Mains schedule on page W-15 we noted that in the footnotes it is explained that the main additions were paid for by the village. Please explain why the \$2,410 for those mains was credited to Account 271 on page F-17 instead of Account 200 on page F-12.
3. During our review we noted 312 services in use reported in the Water Services schedule and 396 customers reported on page W-2. Please confirm that there are a significant number of services with multiple customers per service.
4. During our review we noted that according to our calculations, the amount the utility reports for public fire protection service billed per Rate Schedule F-1 in Account 463 on the Other Revenues (Water) schedule, page W-4, differs from our calculation by \$426 (see enclosed worksheet). Please provide an explanation of how the utility arrived at the number reported on line 1 of Account 463, Public Fire Protection Service on page W-4. Please also follow our method of calculation in the future.

We appreciate your cooperation in providing the above information. These recommendations are intended to provide accounting assistance and should not be construed as criticisms of utility personnel. If you have any questions, please feel free to contact me at (608) 267-9198. Please respond within 30 days of this letter. We prefer that you respond by e-mail if it is convenient for you to do so.
