The Public Service Commission staff is in the process of completing an analytical review of your utility's 2000 annual report. The purposes of an analytical review are to detect possible reporting or accounting related errors and to identify significant fluctuations from established trends in reported data not sufficiently explained in the annual report. It is our hope that this review will supply information that will enable us to better provide guidance to your utility regarding proper utility accounting and the preparation of future annual reports. In order to complete this review, we request the following information:

1. As directed in the head notes of the Water Services schedule on page W-16, please provide an explanation of how the service reported as added during the year was financed and follow this procedure in the future.
2. As directed in the head notes of the Water Operation & Maintenance Expenses schedule on page W-5, please provide an explanation of any expense account which changed by \$2,000 and 30 percent when compared to the previous year and follow this procedure in the future.
3. We appreciate the response from Jeffrey D. Parker, Director of Public Works, to our letter of January 4, 2001, regarding minimizing water loss. We understand that you have a meter testing program for all sizes of meters, that some leaks have been repaired and the plan is to continue to find and repair them. Has the meter been purchased for flushing at hydrants? What are the last two quarterly results of comparing water sold to water pumped? Since your unaccounted percentage is still at a high level, we will continue monitoring this and working with you as needed to help your utility improve in this area.
4. We have enclosed our copy of the Public Fire Protection Service charge calculation, pro rated between the old rate and the new rate effective July 3, 2000. The difference between our calculation and the amount reported in Other Revenues (Water), Page W-4, is \$2,842. Please adjust your 2001 Public Fire Protection Service charge to include the \$2,842 undercharged in 2000. Please follow our procedure for calculating the charge in the future.

We appreciate your cooperation in providing the above information. These recommendations are intended to provide accounting assistance and should not be construed as criticisms of utility personnel. If you have any questions, please feel free to contact me at (608) 267-9198. Please respond within 30 days of this letter. We prefer that you respond by e-mail if it is convenient for you to do so.
