FULL-TIME EMPLOYEES (FTE)

Example: An employee worked 35% of their time on electric jobs, 30% on water jobs, 20% on sewer jobs and 15% on municipal nonutility jobs. The FTE by industry would be .4 for electric, .3 for water and .2 for sewer.

During 2006, the Utility installed two diesel generators one at Well #3 and one at Well #6. The entire cost of the project was \$498,232. The Utility paid \$404,801 out of their operating cash and reserve bank accounts. The remaining \$93,431 was paid for by a Community Block Development Grant.

Water Mains (Page W-21)

If Added During Year column total is greater than zero, please explain financing following the criteria listed in the schedule headnote No. 5.

In 2007 1,175 feet of 8" main was installed along Highway 81 to serve Pleasant View Nursing home. The Water Utility paid for \$30,995 out of operating cash and the Green County paid \$28,294 for the installation.

Water Services (Page W-22)

If net additions are greater than zero, please explain financing by following criteria listed in schedule headnote No. 3.

In 2007 6 new 1" copper services and 1 new 3/4" copper service was added. The 3/4" services was installed and paid for by the Utility out of operating funds. Bakersfield subdivision had one 1" copper service placed into service during 2007. This service was paid for by the developer. Another 1" copper service was installed for Pleasant Nursing Home. That service cost \$11,040 to install. The Utility paid \$5,520 out of their operating funds and the remaining \$5,520 was paid for by Green County. The remaining four 1" copper services were installed and paid for by the Utility.

Meters (Page W-23)

The Utility has a 10 year maintenance program for 1" or smaller. During the 10 year period, the Utility tries to replace the customer's meter with a new meter and the old meter is tested and repaired if necessary
